Slide 1 – Introductory Comments

Introduction of presenter(s)

The purpose of this presentation is to provide a summary of the key changes that are being implemented to support and progress the Zone 8 Regionalisation Pilot.

The Pilot is one of only two Rotary International approved pilots in the world, the other being in Rotary Great Britain and Ireland.

Slide 2 – The why

The pilot is about trialing a new Governance model in Zone 8, supported by a new operating model. The new operating model will provide a platform for:

- Developing and delivering on multi-year strategies to enhance Rotary's profile and footprint across Zone 8
- Harnessing the best practices that are identified by clubs and members and sharing these consistently across the zone to strengthen our operations and outcomes
- Reducing time spent on administration processes across the zone by removing duplication and introducing automation of common processes.
- Empowering clubs and their chosen community of clubs to develop local goals and to enable more collaboration to achieve these.
- Identifying members who have recognised skills and experience, to act as Rotary Specialists to support clubs across the Zone.

This is a big vision, so how are we getting started?

Slide 3 Pilot operating model

The Pilot is introducing a new operating model which features three new groups of volunteer roles who will work to support Rotary and Rotaract clubs and members to maximise their goals and outcomes.

- •First is the Regional Council, which will be the leadership body for Zone 8 and will be responsible for setting strategies, goals to align with Rotary's Action Plan and the goals defined in the Pilot proposal.
- •The second is Rotary Community Leaders, who will facilitate collaboration between groups of clubs and connect clubs and members to specialists and support resources as required.
- •The third are Rotary Specialists, a very important role where volunteers provide their skills, knowledge and experience to Clubs, groups of Clubs and members.

In this presentation, we're now going to focus on the Regional Council and Community Groups and Rotary Community Leaders.

More info on Rotary specialists will be provided in the near future.

Slide 4 Regional Council Structure

Expressions of Interest are currently open for the following Regional Council roles.

All roles have a two year term, except the Rotaract Nominee and Rotary Community Leader Nominee.

The **Regional Council Chair** will be responsible for leading and managing the Regional Council. This includes ensuring the Council focuses on its agreed mission, vision, and strategies without preference to geography or interest.

The **Regional Council Chair Elect,** while preparing for their future role as Chair, will be responsible for developing, communicating, and managing the Zone Strategic Plan and ensuring the voices of all countries and regions are heard. To ensure there is strong representation from all Island nations, it is proposed that the Chair Elect will lead a **Multi-National Advisory Committee** in which members will represent the perspectives of their countries. The Chair-elect will also liaise with existing Rotary entities, like RDU, RAWCS etc.

There are **six Portfolio Lead roles** who are accountable for outcomes in their respective portfolio area:

- Service Projects and Programs
- Public Image and Partnerships
- Membership (Growth, retention and new club creation)
- Learning and Development
- Fundraising and Grants
- Diversity, Equity and Inclusion

The **Rotaract Nominee** will be tasked with ensuring Rotaract perspectives are considered as the Regional Council develops new programs and initiatives to increase the reach and success of Rotaract and Rotary across the Zone.

This is an excellent opportunity for experienced Rotaract members to put themselves forward for election to contribute to Rotary administration and governance at a regional level and to support and promote the strengthening of Rotaract in Zone 8.

Only active Rotaract members are eligible to apply for this position which is a minimum 1 year term. Rotaractors are also able to apply for all other positions on the Regional Council.

The **Rotary Community Leader Nominee** election will be conducted in 2024, after Rotary Community Leaders have been selected.

The **Corporate and Administration** role is a *non-voting position* on the Regional Council and the role description is currently being finalised and will be shared in due course.

All roles on the Regional Council are volunteer roles and not paid. Some expenses will be reimbursed.

It is important to note that the existing Districts will remain in place during the pilot. Some responsibilities will be transitioned from Districts to the Regional Council, Rotary Community Leaders and Rotary Specialists during the course of the pilot.

Slide 5 - Regional Council election timeline

- •Any Rotary or Rotaract members who are interested to apply for roles on the Regional Council need to lodge their online Expression of Interest by 4 September 2023 12pm AEST.
- •An email will generate to their nominated club officer for certification that the member is in good standing.
- •On 5 September, all eligible applicants will receive an application pack for their completion.
- •A small Panel will review applications, to confirm that applicants meet the criteria.
- •The Panel will then announce the candidates for the election.
- •Club Presidents will receive electronic ballot forms on 17th October, to input the ballot on behalf of their club.
- •Election results are expected to be announced on 1 Nov.
- •There will be a 15 day objection period.
- •Full details of the Election process are available on the creatingtomorrowrotary.org website.

Slide 6 - Rotary Community Groups and Leaders

- •As part of the Regionalisation Pilot, a new way of grouping Rotary and Rotaract clubs will soon be introduced. Each group will be known as a Rotary Community Group (RCG).
- •These groups are designed to foster greater collaboration among clubs so they can work more effectively and at a larger scale than they could on their own.
- •RCGs will be based on what clubs have in common, such as geography, type of club or shared language. They will meet in person, online, or a combination of both, and will choose how often they meet.
- •Each District will have their own approach to forming RCGs, tailored to suit their unique needs.

- •In September, Club Presidents and Secretaries will receive a link via email to an online form through which they can specify how they would like to be grouped with other clubs.

 Each club will submit **one** form.
- •Clubs will be able to nominate both a primary and secondary way they prefer to be grouped. Secondary groupings are optional and will mainly be online.

Slide 7 - Rotary Community Groups and Leaders

Each Rotary Community Group will elect their own Rotary Community Leader (RCL), a facilitator who will provide and access support for the clubs in their group as needed.

Rotary Community Leaders will support clubs to:

- -Establish larger scale partnerships
- -Increase community impact
- -Build a higher public profile within their community
- -Attract new club members
- -Increase club member engagement and satisfaction

Slide 8 - Rotary Community Group Collaboration

The Pilot Establishment team have been conducting some workshops with District teams in recent weeks and these are some of the larger scale, more impactful possibilities they imagined:

- •Upscaled tree planting or recycling initiatives in partnership with local government
- •Projects on a 100km walkway connecting several small communities e.g. seating, disability access, photo spots, native planting sites, etc. featuring Rotary signage
- •Mobile clinics for people who find it difficult to access services in partnership with relevant agencies
- •Billboards on freeways/motorways "Rotary, there when you need us", with an image of Rotarians supporting local people affected by floods/fire/earthquake

Slide 9 - Rotary Community Groups and Leaders timeline

The timeline for identifying Rotary Community Groups and Community Leaders is:

- In September, Rotary and Rotaract clubs will be provided a survey to indicate how they would like to be grouped together for future collaboration on activities and projects.
- District leaders and the Regionalisation team will review the survey results together and work on the groupings, in liaison with the clubs where needed.
- The new Community Groups are expected to be advised to clubs by November.

- RCGs will then meet to determine how they will collaborate together and how the RCL role will work for their group
- Club members will then be invited to express interest in nominating for a Rotary Community Leader role in their Community Group. This is likely to be in January.
- Community Leaders will then be elected by March 2024 to enable them to participate in a learning program in preparation for their new role to commence in July 2024.
